Your personal information may also be used by third parties who are responsible for registering pets and enforcing the By-Law to Regulate Dogs. Once the registration is complete, with your consent, the personal information you entered to register your pet, may be used by DocuPet for non-municipal purposes such as a rewards program they offer and for lost and found notifications.
